

3 Year Warranty and Cashback Promotion

Terms and Conditions

Promotion & Promoter

1. The Promoter is **Canon CEE GmbH**, registered at Oberlaaer Strabe 233, 1100 Vienna, (hereinafter referred to as “Canon”).

2. For the selected Canon Products (“Promotional Products”) detailed below, this *3 Year Warranty* (“Promotional Warranty”) and *Cashback Promotion* offers Cashback (values detailed below) and a warranty extension:

Extension = An extension to the existing applicable Canon commercial warranty to make such warranty 3 years.

3. Except as explicitly amended herein (by extension), the existing Canon commercial warranty applicable to your product shall apply to the warranty services provided under this Promotional Warranty. In the event of any conflict between the terms of the services provided under this Promotional Warranty and those of the Canon Commercial Warranty, the terms of this Promotional Warranty shall prevail.

Promotional Period

16. Canon reserves the right to invalidate any incomplete, incorrect or unsubstantiated claim.

17. For cashback claims, upon receipt and verification of the claim, Canon will arrange for a direct BACS transfer payment of the applicable amount set forth in clause to the Participant's bank account specified in the claim. No alternative arrangement will be entered into and no cash or cheque will be provided.

18. Canon will endeavor to make cashback payments within 28 days of receipt of a valid claim.

19. Where a Participant fails to select one of the currencies offered in the claim form, one may be allocated at Canon's absolute discretion.

20. Only one BACS payment will be issued per valid claim.

21. If you are VAT registered and you receive a cashback, it may reduce the taxable value of your purchase and so you may need to reduce your input tax accordingly. You are responsible for any tax liabilities that may be applicable.
