1. PROMOTIONAL PRODUCTS, PROMOTIONAL PERIOD AND PARTICIPANTS

1.1. This promotion is only available on purchases made of any of the products listed below/attached (the “**Promotional Products**”) within Malta from an authorised Maltese retailer until the 31.12.2019. Promotional Products can be sold as a camera body only or part of a lens kit or bundle **but only ONE claim can be made per kit or bundle**. So, if a kit includes two Promotional Products, the Participant will need to pick one product against which to make a claim. Purchases must be genuine purchases for cash or its equivalent.

1.2. All Participants must be current of newly accepted students, aged 18 or over, must owe a valid student card and must be resident in the Maltese Islands. (“**Participant**”).

1.3. All Participants are deemed to have agreed to be bound by these terms and conditions.

2. HOW TO PARTICIPATE
