

## Lottery Terms and conditions

This competition is being organised and promoted by Avantech Group, registered at Avantech Building, St Julian's Road, San Gwann, SGN2804.

All walk-in clients purchasing directly from the retail shop at the Avantech showroom can participate by using the receipt (invoice or cash sale) against their purchase.

### Lottery Time Frame:

- a. The Scan2Win Lottery will be held every two months.
- b. The winners will be drawn and announced on the last Friday of February, April, June, August, October and December.
- c. New submissions will start being accepted from the day following the end of every draw.

### Winners and Prizes:

- a. There will only be one winner per draw.
- b. The winner will win a €100 voucher from Avantech.

### Eligible participants and entries:

- a. The Scan2Win Lottery is open to all walk-in clients, aged 18 and over, who make a purchase for a product or a service directly from the retail shop at the Avantech showroom in San Gwann. This includes private companies, NGOs and Government entities. In the case where the participant is a private company, NGO or Government entity, the representative shall complete the entry to the lottery using the company's details.
- b. People under 18 years of age are not eligible to participate.
- c. Clients buying online are not eligible to participate.
- d. Avantech staff and their immediate family members are not eligible to participate in this lottery.
- e. Each receipt number can be used only once to enter the lottery. Every unique receipt number (invoice or cash sale number) is equivalent to one unique entry.
- f. First draw will include March and April 2022, and each subsequent draw will include receipts dated after the last draw.

### How it works:

- a. Purchase any product or service from the retail shop at the Avantech showroom in San Gwann.
- b. Scan your receipt (invoice<sup>1</sup> or cash sale) at the Scan2x stand in the Avantech showroom.
- c. Confirm your details on the Scan2x screen.
- d. Enter lottery by clicking 'Submit' on the Scan2x screen.
- e. An automatic email will be sent to each participant confirming the submission.

<sup>1</sup> The invoice being used to enter the lottery must be fully paid by the draw date. Invoices with an outstanding balance will be automatically disqualified.

**Winner:**

- a. The winner will be picked randomly via an automated computerised system.
- b. The winner will be announced on the same day of the draw on the [Avantech website](#) and social media platforms ([Facebook](#) and [Instagram](#)).
- c. In case of a private company, NGO or Government entity, should the respective receipt be drawn, the prize will go to the company and not to the representative who had submitted the entry.
- d. Presentation of prizes to the winners will take place at the Avantech showroom in San Gwann on an agreed date between an Avantech representative and the winners.
- e. During the presentation the winners will be asked to pose for a photo. The photo will be posted on our online media platforms.

**Claiming the prize:**

- a. The winner must claim the prize within 1 month from announcement date. Prizes that are not claimed after the stipulated period will be lost.
- b. Prizes can only be claimed for by the individual in whose name the Scan2Win Lottery entry has been submitted. In case of a private company, NGO or Government entity, an appointed representative will be presented the prize on behalf of the company.
- c. A valid proof of identity document will be required to be presented for the collection of the voucher.

**Redemption of voucher:**

- a. The voucher is only redeemable at the Avantech showroom.
- b. The voucher can be redeemed against the purchase of any of the products offered by Avantech Group. This includes any product offered by Avantech Limited and Corex International.
- c. Voucher cannot be exchanged for cash.
- d. In case of a lost voucher it is at Avantech's discretion on whether to issue a new one or not. In such cases a proof of identity may be requested.

**Others:**

- a. By entering the Scan2Win Lottery participants will be deemed to have agreed to be bound by these rules.
- b. Avantech Group reserves the right to exclude any entry from the lottery at any time and in its absolute discretion, if Avantech Group has reason to believe that a participant has breached these rules.
- c. Avantech Group reserves the right to refuse participation to the Scan2Win Lottery to any person if:
  - i. for some legal reason they are not allowed to participate in lotteries.
  - ii. the proof of purchase provided is deemed unacceptable by the administrator.
  - iii. the proof of purchase is falsified or there is suspicion it has been tampered with.
  - iv. is caught to be cheating.
- d. Avantech Group reserves the right to cancel this lottery or alter any of the rules at any stage, if deemed necessary in its opinion, and if circumstances arise outside of its control.

**Data Protection Notice**

- a. Avantech Group processes, uses and stores the data submitted by the participants upon submission for the duration of the lottery, in order to properly implement and manage the lottery.
- b. Neither Avantech Group nor any third-party partner of Avantech Group will use such data for any further purposes without written consent of the respective participant.
